Sample Drop-in Use and Payment Scenarios

Sample Scenario 1: A child goes to Extended Day from 7:20-7:50 am. The charge is \$12.

Sample Scenario 2: A child drops in at 4:20 pm after an enrichment course and stays until 6:00 pm. The charge is \$24.

Sample Scenario 3: The first child of a family stays in Extended Day from 12:15-3:45 pm, and the second child in the family stays from 12:15-4:30 pm. The family is charged \$108.00 for that day.

Payment Options

- Plan A or B – Invoiced Sept.-June/Families may pay by FACTS*, credit card, cash, or check.
*You must be registered for FACTS to elect this option.
- Drop-in – Families may pay by credit card, cash, or check only.

Terms of Contract

1. There is an annual, one time registration fee of \$30.00 per family to cover the cost of our electronic attendance program. In anticipation that your child(ren) will not use Extended Day and you do not elect to pay this fee at the time of registration, it will be charged upon the first time you use Extended Day.
2. Payment for usage is due each month upon receipt of the invoice. Invoices will be sent on approximately the 5th of each month via backpack mail.
3. After a one-time notification, a late fee of \$25.00 will be assessed for outstanding fees for one month. A continued non-payment of fees may be cause for dismissal from the Extended Day program.
4. After 6:00 pm, a late charge of \$5.00 a minute per child is applicable.
5. Improper behavior as described in the Saint Ann Catholic School Parent/Student Handbook may be cause for dismissal from the Extended Day program.

Extended Day Contract 2019-2020

All students in grades Pre-K 4 Full Day through eighth grade are required to complete and submit an Extended Day Registration Form, including the contract. Registration ensures that every student can be supervised in the event of an unexpected emergency. To help us better serve you and make necessary preparations, the registration **due date is August 22, 2019.**
